



## **TERMS & CONDITIONS**

### **CAMPAIGN “ALTEL LOKAL”**

<b>1.Organiser</b>	Net2One Sdn Bhd [“ALTEL”].
<b>2.Campaign</b>	ALTEL LOKAL [“Campaign”].
